STRIDES ARCOLAB ANNOUNCES USFDA APPROVAL FOR MESNA INJECTION

TOTAL APPROVALS IN STERILE SPACE AT 21

Strides Arcolab Limited (Strides) today announced receipt of ANDA approval for its Abbreviated New Drug Application (ANDA) to market Mesna injection (Mesna), a prophylactic agent used to reduce the incidence of hemorrhagic cystitis caused by Ifosfamide chemotherapy. Mesna will be available in 1 mg per 10 mL multi-dose vials, offered in single packs and in packs of ten. According to 2009 IMS data, the U.S. market for Mesna approximated \$12 million. This is expected to be launched shortly.

Ravi Seth, Chief Executive Officer – International Operations of Strides stated: "This is our second product approval in this month and the fifth for the partnership with Sagent. We are excited by the growth prospects of our business in USA "

Mesna is the fifth product being launched under the partnership between Strides and Sagent Pharmaceuticals wherein Strides is developing and supplying more than 25 injectable products for the U.S. market which will be marketed by Sagent .
