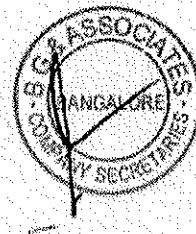

8. The result of the e-voting together with that of the Poll is as mentioned in the Annexure, enclosed to this report, in respect of the said Special Resolution.


The resolution stands passed under e-voting and Poll with the requisite majority.

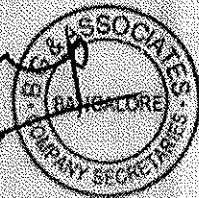
